## Membership Fee / Request for reduction

The amount of the contributions is determined at the regular meeting of members in accordance with the statues of the bbk berlin e.V. The annual fees are currently: 1.) 116 Euro regular 2.) 85 Euro reduced 3.) 30 Euro for students.

- 2.) A reduced membership fee can be requested by artists who are
  - a receiving benefits under the Social Security Code II (Arbeitslosengeld II),
  - b pensioners who are obtaining legal basic income or which pension entitlement does not exceed such. The request for reduction is awarded annually and is valid for one year. Relevant evidence has to be provided unrequested for each year. If no evidence is provided the regular membership fee applies automatically.

3.) The reduced membership fee for students will be granted to artists who are still inscribed to a course of Fine Art at a state recognized Art University or College. It is granted for 2 years after submission of the certificate of matriculation. As soon as a degree within the corresponding subject is submitted, the regular membership fee applies. Upon submission of an enrollment certificate the student tariff can be extended.

Notice: In accordance to § 6 Abs. 2. of the statues of the bbk berlin e.V. a termination of the membership must be declared in writing at the latest on the 1 <sup>st</sup> of October of each year and will take effect at the end of the year. For members with a student tariff who are not showing evidence of a corresponding degree or enrollment certificate, the membership will end automatically. New members who terminate their membership after 3 months of the entry date, can resign with immediate effect, as long as a processing fee of 30 Euro is being paid.
